Criminal Sexual Assault Arrest

**Niles, IL** - On 06/13/2016 at about 2 a.m. the Victim a 17 yoa Juvenile Female reported that she had been sexually assaulted on 6/10/2016. Niles Officers and Investigators met with the Victim as well as her father who related the following.

The victim reported she was in the offender's vehicle when he parked his vehicle in the 7200 blk of Lill, the car was described as a 2009 Mitsubishi sports car. The victim related that she had been picked up by the offender and was hanging out with two other teens in Glenview for about 20-30 minutes/ They all went back to the offender's residence in Des Plaines for another 45 minutes. All four subjects then left and the two other teens were dropped off at their residence in Niles. The victim then asked the Offender to take her home. The Offender stopped and parked his vehicle near the 8500 blk of Merrill Street. The victim attempted to exit the Offender's vehicle, but he locked the doors and then proceeded to drive away from the victim's residence. He then parked the vehicle in the 7200 blk of Lill street. The victim became nervous and started to text her friends. He then grabbed the victim's cellphone out of her hand, throwing it on the floor and forcibly grabbing her hair. The victim began to fight back, striking her head on the offender's head, he became enraged and slammed the victim's head multiple times on the car's console. The victim attempted to exit the car again and the offender locked the doors. The offender then demanded the victim to perform a sex act on him and he implied he had a knife if she didn't comply. The victim was forced to perform a sex act. The offender took several photographs of the victim using his cell phone after the sex act was completed. Later the Offender began sending text messages to the victim's cellphone threatening to "blackmail" her with the photographs.

On 6/14/2016 at about 4 pm the Offender was located and taken into custody. He was interviewed and the facts of the case were reviewed by the Cook County States Attorney's Office, Assistant States Attorney Heinlen. ASA Heinlen approved one count of Aggravated Criminal Sexual Assault, 720 ILCS 5/11-1.30 (Class X Felony), and one count of Unlawful Restraint, 720 ILCS 5/10-3 (Class 4 Felony). The offender has an initial court date of June 30, 2016 at 10:30 am in room 105 at the Cook County District 2 Court House, 5600 Old Orchard Road, Skokie IL.
